What is Addiction?

Addiction is a treatable, chronic medical disease involving complex interactions among brain circuits, genetics, the environment, and an individual's life experiences. People with addiction use substances or engage in behaviors that become compulsive and often continue despite harmful consequences.

Prevention efforts and treatment approaches for addiction are generally as successful as those for other chronic diseases.

Substance Use and the Brain

- Every thought, mood, and emotion starts with a message between neurons in the brain.
- Brain neurons adapt and become altered by repeated activity.
- Alcohol and other drugs disrupt this system by substituting the drug for the brain's natural neurotransmitters.
- Drugs activate the brain's reward center, releasing neurotransmitters, such as dopamine.
- The more someone uses substances, the less they feel the rush and the more they need to use to feel normal. This is called tolerance.





Signs of Substance Use Disorder

A substance use disorder involves changes to the brain that include tolerance, withdrawal, compulsive drug seeking despite negative consequences, cravings and an inability to control drug use.

Some signs:

- · Inability to control drug use
- · Compulsive drug use
- · Continued drug use despite harm
- · Cravings for the drug

RECOVERY-ORIENTED Systems of Care

Recovery-oriented systems support person-centered and self-directed approaches to care that build on the strengths and resilience of individuals, families and communities to take responsibility for their sustained health, wellness and recovery from alcohol and drug problems. (CSAT, SAMHSA)

KORE offers Kentucky an opportunity to dedicate much-needed resources to address five overarching goals: (1) preventing opioid misuse and abuse; (2) increasing access to OUD (opiod use disorder) treatment services, including medication-assisted treatment; (3) increasing the



availability of recovery support services designed to improve treatment access and retention and support long-term recovery; (4) increasing availability of naloxone; and (5) enhancing statewide coordination and evaluation of healthcare and public safety strategies targeting opioid misuse and overdose.

In Recovery-Oriented Systems of Care (ROSC), organizations are guided by a set of values, goals, elements, core functions and outcomes to achieve the ROSC's mission. To promote the health of individuals, families and communities, a public health approach is adopted. Substance use disorders are biopsychosocial conditions. These conditions are influenced by various social determinants of health, for example, the social and physical environment, income, education, and life skills. Only by understanding these determinants and applying to influence them can the disease be impacted. (CSAT, SAMHSA)



Goals of Recovery-Oriented Systems of Care:

- · Multi-system care team approach.
- · To keep women and their families from "falling through the cracks."
- Assures everyone is able to receive an appropriate level of ongoing support of sufficient duration to promote possible outcomes for families and children.
- · Goes beyond making referrals or warm handoffs.
- Planning needs to be embedded within a system of care that targets multiple levels of care (individual, family and beyond).
- Planning targets women and families at three points of intervention: Pregnancy, time of birth and at least two years postpartum.

Epidemiology



In 2015, more than 27 million people in the United States reported current use of an illicit drug or misuse of prescription drugs in the past 30 days (Center for Behavioral Health Statistics and Quality [CBHSQ], 2016). The number of women of childbearing age, defined as ages 15 to 44, who reported past-month heroin use increased to 109,000 in 2013–2014, an increase of 31 percent from 2011–2012 (CBHSQ, 2015, Table 6.71A).

> The number of women ages 15 to 44 who reported past-month misuse of prescription pain relievers such as OxyContin© increased to 98,000 in the same period, an increase of 5.3 percent (CBHSQ, 2015, Table 6.71A).



The Centers for Disease Control and Prevention (CDC) estimates that one-third of reproductive-age women enrolled in Medicaid and more than one-quarter of those with private insurance filled a prescription for an opioid pain medication each year between 2008 and 2012 (Ailes et al., 2015). The prevalence of OUD during pregnancy more than doubled between 1998 and 2011 to 4 per 1,000 deliveries (Maeda, Bateman, Clancy, Creanga, & Leffert, 2014).

Neonatal Abstinence Syndrome (NAS)

Neonatal Abstinence Syndrome (NAS) is a group of physiologic and neurobehavioral signs of withdrawal that may occur in a newborn who was exposed to psychotropic substances (e.g., opioids) in utero. Opioid use, whether resulting from prescription misuse or from illicit use, has consequences for the mother-infant dyad, with anywhere from 50 to 80 percent of opioid-exposed infants developing NAS (Jones, Chisolm, Jansson, & Terplan, 2012; Patrick, Dudley, et al., 2015).

From 2009 to 2012, the number of infants diagnosed with NAS increased from 3.4 to 5.8 per 1,000 hospital births, with more than 20,000 infants diagnosed with NAS in 2012 (Patrick, Davis, Lehmann, & Cooper, 2015). The rate of NAS per 1,000 hospital births is not uniform across the nation; rates in rural regions are generally higher than those in urban regions (Villapiano, Winkelman, Kozhimannil, Davis, & Patrick, 2017).

The increase in numbers of infants with NAS, along with other complications, and approach the hospital takes to treating NAS contributes to substantially increased hospital costs, with an average mean charge of \$93,400 in 2012 dollars (Patrick, Davis, et al., 2015).



Too often, pregnant woman with Opioid Use Disorder (OUD) receive no, or very little, prenatal care. With no healthcare professional to monitor their pregnancy, women with OUD may present in a hospital emergency department late in pregnancy or in labor. This happens because women may not recognize they were pregnant, fear being incarcerated for illicit drug use or for exposing their fetus to illicit drugs, lack funds to pay for services, transportation or daycare, and/or fear losing custody of their other children (Howard, 2016).

Attending to the woman's immediate needs is important. For any pregnancy, the healthcare professional's priority is to ensure the well-being of the woman and fetus. In the context of a possible Substance Use Disorder (SUD), learning as much as possible about her opioid use (i.e., type, amount, route, duration, and time of last use) provides the foundation for possible treatment. It is critical to know whether she is on pharmacotherapy for OUD and, if so, which medication she receives so that it can be continued as appropriate. If she is receiving or desires SUD treatment, obtain her consent to communicate with her treatment provider or have a care manager facilitate an effective referral.

For women who are already on pharmacotherapy for OUD and then become pregnant, it is important to collaborate with all healthcare professionals in order to secure the kinds of information releases that will be necessary to coordinate care among those who write pharmacotherapy prescriptions, those who may manage other behavioral health issues, and those providing prenatal care.

Pregnancy is a time of great potential for positive change. A woman with OUD may be motivated to enter treatment not only out of concern for the health of the fetus, but also because during pregnancy she can envision a different future for herself and her child. In the past, it was generally believed that people with OUD could not successfully stop smoking or using other substances while they discontinued opioid use. However, when people are motivated to change, either to achieve a positive outcome or to avoid a negative one, they may be more successful at discontinuing substance use if all the addictive substances they are using are addressed at once, whether alcohol, tobacco, or illicit drugs, including opioids. SUD is recognized to be a chronic disease with expected lapses.

The pregnant and postpartum woman with OUD should be encouraged to keep trying, through a combination of pharmacotherapy and behavioral interventions, not abstinence, to reach the goal of ending substance use. However, it is important to recognize that immediate and simultaneous discontinuation of all substances (e.g., alcohol, benzodiazepines, opioids) may not be feasible or even safe, particularly during pregnancy because of the additional risk to the developing fetus, which may also be going through withdrawal unmonitored. Withdrawal from one or multiple substances may require inpatient care (ASAM, 2015; Commonwealth of Pennsylvania, 2016; Jones et al., 2008, 2016; McCarthy, Leamon, Willits, & Salo, 2015; Meyer & Phillips, 2015).

LifeSkills, Inc. Outpatient-Based Opioid Treatment (OBOT) Program

For individuals seeking recovery from opioid use in an outpatient setting. A comprehensive approach is used to help clients begin and/or continue their new lives in recovery. When appropriate, recovery may be assisted by certain medications that support longer-term engagement in treatment.

A substance use assessment is required to determine admission into our program. People who reside within LifeSkills' ten-county service region are referred to the center through Single Point of Entry (SPOE), inpatient, and outpatient services. Individuals may also be referred by other community agencies and partners.

Primary Focus

This program's primary focus is to treat individuals who are suffering from opioid addiction, offering integrative programming to treat opioid use disorder. Based on The Hazelden Betty Ford Foundation's Comprehensive Opioid Response with the Twelve Steps (COR-12) Treatment Model, emphasis is on "the long-term commitment to recovery and encompasses family, support groups, accountability and the recovery community." While our program utilizes medical management as a tool to treat a chronic condition, the main focus is therapeutic treatment for opioid use disorder.

Program Model

Our Outpatient-Based Opioid Treatment (OBOT) program is based on The Hazelden Betty Ford Foundation's Comprehensive Opioid Response with the Twelve Steps (COR-12) model. This model "employs evidence-based practices along with the wisdom and healing power of Twelve-Step recovery to help individuals with opioid use disorders achieve stable recovery."

Treatment Elements

Elements of OBOT include:

- Medical Opioid Withdrawal Management (if medically indicated)
- Comprehensive Assessment
- Education on Medications for Opioid Use Disorder and Different COR-12 Treatment Pathways
- Individualized Treatment Planning
- Individual, Educational and Group Therapy
- · Family Engagement and Education
- Peer Support with Integration to 12-Step Recovery Community
- Case Management
- Medications for Opioid Use Disorder (based on most appropriate COR-12 pathway)
- · Re-engagement and Relapse Prevention
- COR-12 Path to Lifelong Recovery

Any at-risk pregnant or parenting woman or anyone who knows a pregnant or parenting woman using or at risk of using opioids can make a referral with an ECC to help families get the resources they need.

The ECC can also refer children ages 0-5 to Early Childhood Mental Health Specialists for early interventions.

CASE MANAGEMENT

Services are offered to pregnant and up to 60 days postpartum mothers who have mild, intermediate, or severe substance use disorders. Treatment is not required to receive services. Case Management services can last up to 12 months and include; community partner referrals, one on one meetings, assistance with navigating LifeSkills services, and treatment options.

Department of Community Based Services

The Department for Community Based Services (DCBS) is responsible for child and adult protection, foster care and adoption, and services to enhance family self sufficiency, including food stamps and cash assistance.

Assistance Programs

Supplemental Nutrition Assistance Program (SNAP) - helps individuals and families stretch their food budgets and buy healthy foods.

SNAP Overview

- Kentucky Transitional Assistance Program (KTAP) provides cash assistance to families with children to help pay for basic needs such as rent, utilities, and other household expenses.
- **Medicaid** offers assistance to help cover costs for needed medical care including preventive health care.
- Child Care Assistance Program offers assistance to working families to pay for Child Care services.
- Kentucky Integrated Health Insurance Premium Payments Program (KI-HIPP) – offers employees reimbursement for premiums paid for employersponsored health insurance, including Retiree Health/COBRA/United Mine Workers Insurance, if found cost-effective to the Commonwealth.

Kentucky State Police Angel Initiative Program

The Kentucky Angel Initiative is a program started by the Kentucky State Police in 2016 with one goal: SAVE LIVES

The Angel Initiative is a pro-active approach offering an alternative escape to those battling addiction. Under this initiative, anyone battling addiction can come to ANY KSP post and get help finding a treatment center. No questions asked.

Objectives of the Angel Initiative:

- To forge partnerships with the community in order to address addiction and prevent overdoses.
- The Angel Initiative only applies to people who voluntarily present themselves. It is not a means to complete a courtordered treatment or to fulfil sentencing obligations.
- The Angel Initiative does not apply to those people encountered during regular law-enforcement duties within the post area.
- Angel Initiative participants shall be treated professionally and compassionately at all times during the intake process.

Disqualifiers for the program:

- An outstanding arrest warrant
- A non-extraditable arrest warrant in another jurisdiction
- A registered sex offender in any state
- The Intake Officer can articulate a reasonable belief the person may harm others
- An unaccompanied minor
- · Has no Photo ID or other means to positively prove their identity

What to expect when you arrive at a post:

- You will need to provide photo ID and insurance card if applicable. Do not let lack of insurance prohibit you from coming. Facilities exist for non-insured individuals.
- Review and sign a Participant Agreement Form granting permission to conduct records check and submit to being searched.
- If you have any drugs and/or drug paraphernalia on your person, you will NOT be charged, jailed or investigated. They will be confiscated and destroyed.
- Intake screening in order to determine best treatment options.
- The intake officer will work quickly to locate a treatment facility to best meet your needs.

Any person who voluntarily enters a Kentucky State Police post and requests help with addiction will be immediately screened into the Angel Initiative.

Services

In Home

The Community Collaborations for Children (CCC) In Home Program provides trained, in-home family service associates to work in the home on a short-term basis with families. The associates identify family strengths as well as areas of concern. The strengths based approach to in home services is designed to promote safe, stable, healthy families and to prevent child abuse and neglect. Program staff also assists families in their ability to utilize community resources. Referrals are accepted through community partners, including but not limited to DCBS. Self-referrals are accepted.

Regional Network

The Barren River Regional Network is comprised of community partners and parents who work to reduce the risk of child abuse and neglect in local communities as well as to strengthen parents and families. Goals include but are not limited to: prevent child abuse and neglect, develop leadership roles for meaningful involvement of parents in development, operation, evaluation and oversight of programs and services, build awareness of child abuse and neglect, and targeting and educating the local community. The Regional Network provides funding for faith-based fatherhood initiatives and Child Abuse Prevention Month activities and events.

Mission Statement

"We team with community partners to provide human services with dignity and respect, empowering people in Southern Kentucky to achieve stability and economic security."



Parents As Teachers - Little Learners is an in-home parent program offered in Warren, Allen, Logan, and Hart Counties and based upon the philosophy that a child's parent is his/her first and best teacher. The Parents as Teachers facilitator provides parents of children ages prenatal to five years with personal monthly home visits. The personal visits consist of parent/child activities, child development information, health/vision screenings, and developmental screenings.

Wee Care Early Childhood Program is an early childhood learning center that strives to provide high quality, affordable childcare to families who are at risk of child abuse or neglect. Wee Care Nursery serves children ages 6 weeks to 5 years old. Wee Care also provides free, respite care and drop-in childcare on an available basis.

Parenting Classes are provided as twelve-week, self-help courses. The program centers on the philosophy that parents can re-learn ways of thinking and behaving through education and replace unwanted, harmful behaviors with new, healthy nurturing behaviors. Parents and their children have benefited tremendously from the components of the parenting classes as evidenced by post-test scores and self-reporting.

CoParenting Classes - Offered the 2nd and 4th Wednesday each month for parentings who are divorcing and/or parents who are not in the same home raising children.

Parent Support Group is the last Thursday of the month for parents and other family members raising children. This group is an open-ended, peer-led group facilitated by the parent educator. The purpose of the support group is to offer a safe, nurturing environment enabling parents to express concerns, work through issues, gain insight from others in similar situations, and make up missed parenting class sessions.

The **Adoption Resource Program** provides services and support to pre/post foster/adoptive families. Services include a monthly support group held in Warren, a lending library of over 400 resources, parent training, recruitment of new foster/adoptive families, and crisis intervention.

Our **Supervised Visitation Program** provides supervised visitation for families who may be experiencing custody, reunification, domestic violence, child abuse, and/or other family crises. This program is a fee-based program and all visitations are court ordered or requested by the Cabinet for Health and Family Services.

If needing Prenatal services, <u>please come by the</u> <u>clinic with your proof of pregnancy (it can be from a</u> <u>health department, pregnancy support center,</u> <u>doctor's office/lab, etc.) to complete your new OB</u> <u>paperwork</u>. Please note, that for OB services we only see Medicaid and self-pay patients. Those with commercial insurance will be referred out to the appropriate provider.

If you are pregnant and uninsured, our receptionist will assist you in completing a PE application, or Presumptive Eligibility for Medicaid prior to your first appointment. This allows you time to complete a full application for Medicaid while starting OB services.

You will be seen once a month during the first 28 weeks, then twice a month until 36 weeks. Beginning at 36 weeks, your will be seen weekly.

Prenatal care & delivery will be provided by an OB/GYN physician or CNM from Women's Health Specialists. Throughout your pregnancy, may see more than one of these providers and the OB "on call" will be responsible for your delivery.

Steps to a Healthy Pregnancy

- Avoid alcohol, drugs, tobacco, litter boxes, chemicals, uncooked meat & jacuzzis.
- 2. Get regular prenatal care!
- Take prenatal vitamins and folic acid.
- Get plenty of sleep & exercise.

Choosing Child Care

More and more, research tells us that our children's healthy development depends on safe and positive experiences during the first few years of life. Choosing high quality child care is one of the most important decisions you will ever make for your child. The 14 researched-based guidelines listed on the back of this handout can help you make the right choice for your child. Please consider the following tips before deciding on a child care program:

- Visit several different child care programs (center or family child care homes).
- Call to schedule an appointment for your visit to ensure the director's full attention to your tour.
- Plan to visit for at least an hour to watch activities, check the surroundings, and ask questions.
- Bring this checklist with you to guide your visit.

Targeted Assessment Program

- The Targeted Assessment Program (TAP) was developed through a contract with the Kentucky Cabinet Health and Family Services and the University of Kentucky Center on Drug and Alcohol Research. The objective of the Targeted Assessment Program is to identify and address multiple barriers to family self-sufficiency and safety among Department for Community Based Services (DCBS) participants, including pregnant and parenting moms. The TAP assessors are trained and experienced in the targeted areas of mental health, intimate partner violence victimization, substance use, and learning problems. The assessors, located on-site at the DCBS offices (Divisions of Family Support and Protection and Permanency (P&P), conduct assessment, pre-treatment, and service coordination focused on identifying and addressing mental health (MH), intimate partner violence victimization (IPV), substance abuse (SA), and learning problems (LP).
- When you refer to TAP, your participant will receive a holistic assessment, individualized plan for addressing barriers, and ongoing services to support engagement and follow-through with needed services. TAP services are free, comprehensive, and participant-focused.

Who is eligible to receive TAP services?

One or more of the following criteria must be met in order for participants to be eligible for TAP services:

- a. TANF eligible: 200% of poverty
- b. Resident of a TAP County (In the BRADD area, this would include Barren and Warren Counties)
- Must have a dependent child(ren)
 If children have been removed, permanency goal is reunification or concurrent planning
- Suspect a barrier in one or more of TAP's targeted areas (substance abuse, mental health, intimate partner abuse/violence, or learning problems) have impacted participant's capacity for family self-sufficiency/safety
